3.	<u>Cofnodion y cyfarfod blaenorol ar y 15fed o Hydref 2020</u> <u>Minutes from the previous meeting held on the 15th of October 2020</u> Derbyniwyd y cofnodion fel cofnod cywir gan y Cyng. Pat Racher ac fe'i eiliwyd gan y Cyng. Rhys Green. <i>The minutes were accepted as a true record and proposed by Cllr Pat Racher and seconded by Cllr Rhys Green.</i>
4.	<u>Materion yn codi o'r cofnodion / Matters arising from the minutes</u> i. Pont Tancoed, Heol Esgairdawe – Mae'r mater hwn mewn llaw. Soniodd y Cadeirydd fod y bolardiau wedi cael ei dymchwel eto. Cytunodd y Cyng. Eirwyn Williams i godi'r mater gyda'r Cyngor Sir. Tancoed bridge, Esgairdawe Road – <i>This issue is in hand. The Chair mentioned that the bollards have been knocked down again. Cllr. Eirwyn Williams to raise the matter with the County Council.</i> ii. Gwefan – Nodwyd fod y Cyng. Pat Racher a'r Clerc wedi dechrau uwchlwytho cofnodion y cyfarfodydd blaenorol i'r wefan newydd. Gofynnwyd am lun gan bob cynghorydd i'w ychwanegu at y wefan. Ar hyn o bryd dim ond y Cynghorwyr Rhys Green a Pat Racher sydd wedi darparu llun. Website - <i>It was noted that Cllr. Pat Racher and the Clerk have started uploading the minutes of the previous meetings to the new website. A photo was requested from each councillor to add to the website. Quick yn y Cyngor Sir. <i>Blocked pipe, near Tancoed bridge - The Chair mentioned that the pipe was still blocked. Cllr. Eirwyn Williams to note the problem with S. Quick in the County Council.</i>
5.	<u>Dyfodol Adeilad Ysgol Llansawel / The Future of Llansawel School Building</u> Adroddodd y Cyng. Eirwyn Williams bod Ymddiriedolaeth Crochan Cwm Cothi wedi cytuno arwyddo'r brydles. Roedd yr arwyddo i fod i ddigwydd ar y 9fed o Dachwedd, ond oherwydd y sefyllfa Covid bresennol estynnwyd y dyddiad gan ychydig o ddyddiau. <i>Cllr. Eirwyn Williams reported that Crochan Cwm Cothi Trust has agreed to sign the lease. The signing was due to take place on the 9th of November, but due to the current Covid situation the date was extended by a few days.</i>
