1.	<u>Croeso / Welcome</u> Estynnodd y Cynghorwyr groeso arbennig i Jonathan a Sarah Lake sydd wedi ymuno â'r cyfarfod i godi eu pryderon ynghylch y llifogydd sy'n digwydd yn y pentref. Gweler pwynt 11.i. <i>The Councillors extended a special welcome to Jonathan and Sarah Lake who have joined the meeting to raise their concerns regarding the flooding that is happening in the village. See point 11.i.</i>
2.	<u>Ymddiheuriadau am absenoldeb / Apologies for absence</u> Cyng. / <i>Cllrs</i> , Rhys George (Is-gadeirydd / <i>Vice chair</i>) Lynne Jones, Sion Williams, Meurig Griffiths & Elsbeth Jenkins.
3.	<u>Datganiadau o ddiddordeb / Declarations of interest</u> Dim. Nodwyd nad yw Cyng. Pat Racher bellach yn drysorydd yr Ymddiriedolaeth Maes a Neuadd Llansawel. <i>None. It was noted that Cllr Pat Racher is no longer the treasurer of the recreation field and hall trust.</i>
4.	<u>Cofnodion y cyfarfod blaenorol ar y 14eg o Ionawr 2021</u> <u>Minutes from the previous meeting held on the 14th of January 2021</u> Derbyniwyd y cofnodion fel cofnod cywir gan y Cyng. Pat Racher ac fe'i eiliwyd gan y Cyng. Kevin Davies. <i>The minutes were accepted as a true record and proposed by Cllr Pat Racher and seconded by Cllr Kevin Davies.</i>
5.	<u>Materion yn codi o'r cofnodion / Matters arising from the minutes</u> i. Pont Tancoed, Heol Esgairdawe – Mae'r mater hwn mewn llaw. <i>Tancoed bridge, Esgairdawe Road</i> – <i>This issue is in hand.</i> ii. Gwefan – Rydym wedi profi rhai problemau gyda'r wefan newydd. Gofynnwyd i bawb anfon llun ohonyn nhw eu hunain at y Cyng. Pat Racher erbyn y cyfarfod nesaf. <i>Website</i> – We have experienced some issues with the new website. <i>Everyone was asked to send a photo of themselves to Cllr Pat Racher by the next meeting.</i>

	iii. Olwyn Dŵr wedi'i wneud â Llaw – Nid yw'r Clerc wedi cael ymateb eto gan Ynni Sir Gâr i drafod y cysyniad o olwyn ddŵr. Y Clerc i gadw ymholi. <i>Handmade Water Wheel – The Clerk has not yet had a response from Carmarthenshire Energy to discuss the concept of a water wheel. Clerk to keep inquiring.</i> iv. Ardal Ailgylchu – Adroddodd y Cyng. Pat Racher fod yr ardal yn parhau i gadw'n daclus a chytunwyd i dynnu'r pwynt o'r Agenda. <i>Recycling area – Cllr Pat Racher reported that the area remains tidy and it was agreed to remove this item from the agenda.</i> v. Baw Cŵn – Mae'r Clerc wedi rhoi gwybod i'r Cyngor Sir am sefyllfa baeddu cŵn yn y pentref. Mae'r Cyngor Sir yn annog preswylwyr i riportio baeddu cŵn i'r Cyngor Sir ar unwaith ynghyd â'r union leoliad. <i>Dog Fouling – The Clerk has reported the dog fouling situation in the village to the County Council. The County Council encourages residents to report dog fouling to the County Council immediately along with exact location.</i>
6.	<u>Dyfodol Adeilad Ysgol Llansawel / The Future of Llansawel School Building</u> Nodwyd bod gwaith wedi dechrau ar yr hen ysgol. Dim gwybodaeth bellach i'w hadrodd. <i>It was noted that work has started on the old school. No further information to report.</i>
7.	<u>Gohebiaeth / Correspondence</u> i. Diogelu Cymru - fideo i'w uwchlwytho ar ein Gwefan. <i>Keep Wales Safe – video to be uploaded onto our Website.</i> ii. Cylch Meithrin Llansawel – Llythyr yn gofyn am rodd o £900 ar gyfer 2020/21 ac un arall yn gofyn am £900 ar gyfer 2021/22. Cytunwyd i dalu'r swm llawn ar gyfer 2020/21 ac yna mewn 3 rhandaliad, yn ôl yr arfer, y flwyddyn ariannol nesaf. Nodwyd bod y Meithrinfa wedi parhau i ddarparu gwasanaeth trwy gydol y pandemig gan gynnig gwasanaeth i rieni sy'n gweithio ac mae eu rhent hefyd wedi codi. <i>Llansawel Meithrin - Letter requesting donation of £900 for 2020/21 and another requesting £900 for 2021/22. It was agreed to pay the full amount for 2020/21 and then in 3 instalments, as per usual, next financial year. It was noted that the Meithrin has continued to provide a service throughout the pandemic offering a service to working parents and their rent has also increased.</i> iii. Pat Racher drew our attention to necessary work required to the shed. It was noted that the building needed new doors. Clerk to arrange quotes for doors. It was agreed to look at these contributions again after working out our other costs.</i>

iii.	<u>Praesept</u> - Cytunodd y Cynghorwyr i beidio â chodi cyfanswm y praesept ar gyfer 2021/22. Bydd y Clerc yn gwneud cais am £5,500. <u>Precept</u> – <i>The Councillors agreed not to raise the total precept for 2021/22. 10.	<u>Coronafeirws / Coronavirus (Covid-19)</u> <i>Dim / None.</i>
11.	<u>Unrhyw fusnes arall / Any other business</u> i. Llifogydd – Esboniodd Jonathan a Sarah Lake, sy'n byw yn Deluan, bod y draeniau'n blocio yn ystod stormydd gan achosi i'w tŷ orlifo. Gofynasant a fyddai'n bosibl cael arbenigwyr llifogydd / draenio gan y Cyngor Sir neu Dŵr Cymru i edrych ar y broblem. Soniodd y Cyng. Eirwyn Williams ei fod wedi cael trafodaeth gyda syrfëwr am y llifogydd yn Llansawel a bydd yn gwneud trefniadau iddo ddod allan i edrych ar y sefyllfa. Floods - <i>Jonathan and Sarah Lake, who live in Deluan, explained that the drains block during storms causing their house to flood.</i> <i>They asked if it would be possible to get flood / drainage experts from the County Council or Welsh Water to look at the problem.</i> <i>Cllr. Eirwyn Williams mentioned that he has had a discussion with a surveyor about the floods in Llansawel and will arrange for him to come out to look at the situation.</i> ii. Sesiynau hyfforddiant o bell – Soniwyd bod Un Llais Cymru yn cynnig dau le am ddim i gynghorwyr ar bob sesiwn hyfforddi. Gofynnwyd i gynghorwyr gysylltu â'r Clerc os ydynt yn dymuno mynychu unrhyw un o'r sesiynau hyfforddi o bell. Remote Training Sessions – <i>One Voice Wales are offering two free places for Councillors on each training session. Councillors were asked to contact the Clerk if they wish to attend any of the remote training sessions.</i> iii. Cofrestrfa Tir EM - Adroddwyd bod Llywodraeth Cymru yn gweithio gyda Chofrestrfa Tir EM ar brosiect i gofrestru holl dir y Sector Cyhoeddus erbyn 2025, a thir preifat erbyn 2030. Cadarnhaodd y Clerc ei bod wedi cwblhau arolwg a wedi nodi bod y Cyngor Cymuned yn berchen yr hen adeilad hers. HM Land Registry – <i>It was reported that the Welsh Government are working with HM Land Registry on a project to register all Public Sector land by 2025, and private land by 2030. The Clerk confirmed that she has completed a survey and noted that the Community Council own the old hearse building.</i> iv. Llygad-yr-ŷch, Heol Esgairdawe (Pen rhewl Rhiw Draenog) – Adroddwyd bod y ffos yn blocio eto, sy'n achosi llifogydd. <i>It was reported that the trench was blocking again, causing flooding.</i> v. Heol Esgairdawe, nôl at Rhydcymerau (Maesteile) – Adroddwyd bod coed sydd wedi gordyfu yn achosi problemau i lorïau sy'n pasio Fferm Maesteile. Cyng. Eirwyn Williams i godi'r mater gyda'r Cyngor Sir. Soniwyd efallai bod yr ardal yma yn dod o dan y Cyng. Ieuan Davies (Llanybydder a Rhydcymerau). Esgairdawe Road, back towards Rhydcymerau (Maesteile) - <i>Overgrown trees have been reported to cause problems for lorries passing Maesteile Farm. Cllr. Eirwyn Williams to raise the matter with the County Council. It was mentioned that this area may fall under Cllr. Ieuan Davies (Llanybydder and Rhydcymerau).</i>
