2.	<u>Ymddiheuriadau am absenoldeb / Apologies for absence</u> Cyng. / <i>Cllrs</i> Kevin Davies (Cadeirydd / <i>Chair</i>), Lynne Jones, Sion Williams, Meurig Griffiths & Elsbeth Jenkins.

4.	<u>Cofnodion y cyfarfod blaenorol ar y 18fed o Chwefror 2021</u> <u>Minutes from the previous meeting held on the 18th of February 2021</u> Derbyniwyd y cofnodion fel cofnod cywir gan y Cyng. Rhys Green ac fe'i eiliwyd gan y Cyng. Pat Racher. <i>The minutes were accepted as a true record and proposed by Cllr Rhys Green and seconded by Cllr Pat Racher.</i>

Pont Tancoed, Heol Esgairdawe – Mae'r mater hwn mewn llaw. <i>Tancoed bridge, Esgairdawe Road – This issue is in hand.</i> ii. Llygad-yr-ŷch, Heol Esgairdawe – Ffos wedi blocio – Adroddwyd bod y Cyngor Sir yn bwriadu dadblocio'r ffos wythnos nesaf. <i>Llygad-yr-ŷch, Esgairdawe Rd – blocked trench - It was reported that the County Council is planning to unblock the trench next week.</i> iii. Heol Esgairdawe, nôl at Rhydcymerau (Maesteile) – Adroddodd y Cyng. Eirwyn Williams ei fod wedi codi'r mater ynglŷn â'r coed sydd wedi gordyfu gyda'r Cyngor Sir. <i>Esgairdawe Road, back towards Rhydcymerau (Maesteile) - Cllr. Eirwyn Williams reported that he has raised the issue regarding the overgrown trees with the County Council.</i> iv. 	v. Hen adeilad yr hers – Cadarnhaodd y Cyng. Rhys George y bydd Elgan yn rhoi dyfynbris cyntaf i ni ar gyfer drysau newydd i'r adeilad. Y Clerc i anfon anfoneb at y Llew Du am y ffi rhentu ar gyfer yr adeilad am 2019/20 a 2020/21, cyfanswm o £52.00. <i>The old Hears building – Cllr. Rhys George confirmed that Elgan will provide us with the first quote for new doors to the building. The Clerk to invoice the Black Lion for the rental fee for the building for 2019/20 & 2020/21, totalling £52.00.</i> vi. Llifogydd – Adroddodd y Cyng. Eirwyn Williams iddo gyfarfod yn ddiweddar ag S. Quick ac S. Lewis o'r Cyngor Sir i drafod y sefyllfa. Nodwyd bod y Cyngor Sir wedi bod yn glanhau'r draenau a'r cwteri, allai fod o gymorth yn y tymor byr. Nodwyd problem, lle mae'r gwter yn rhedeg allan o'r afon ni all y pibellau ymdopi unwaith y bydd yr afon wedi codi uwchben y bibell. It was noted that the County Council has been cleaning the drains and gutters, which may help in the short term. A problem was identified, where the gutter runs out of the river the pipes are unable to cope once the river has risen above the pipe.
